Duty of Disclosure

- that we know or in the ordinary course of our business we ought to know.
- that we state to you that we do not want to know.

Non-disclosure or misrepresentation

If you make a material misrepresentation to us, or if you do not comply with your duty of disclosure, we may treat your policy as if it never existed.


Data sharing consent
